\$ 500 Scholarship for one boy and one girl

Requirements for applicant:

1. Varsity basketball player.
2. Senior graduating in June.
3. The applicant must be accepted for a course of study beyond high school.
4. Applicant's high school team must be serviced by STBO as listed in the current handbook.

Procedure for applying:
